Our process

Cannabinoids are the therapeutic components of cannabis. There are cannabinoid receptors throughout the human body – primarily in the central nervous system and the immune system, but also in the gastrointestinal, endocrine, and hematopoietic systems. Cannabinoids bind to these receptor sites with the ultimate goal of homeostasis, or balance, of the human body and its systems. Studies suggest the possibility of multiple therapeutic roles for medical cannabis.

- **Step 1:** Schedule a visit with Inclusive Care Group. Our board certified physician, Dr. Luis is qualified by the Office of Medical Marijuana Use to recommend cannabis in the state of Florida
- **Step 2:** Receive your recommendation from Dr. Luis and he will input your patient information into the Medical Marijuana Use Registry
- **Step 3:** Submit a completed Medical Marijuana Use Registry Identification Card application to the Office of Medical Marijuana Use
- **Step 4:** Once you have received your Medical Marijuana Use Registry Identification Card you are able to fill your order at the dispensary of your choice.



Our services

In November 2016, Floridians approved Amendment 2 with an astounding 71% of the vote. So what does this mean? Amendment 2 allows the use of medical marijuana for debilitating medical conditions. There are 9 qualifying conditions listed in Amendment 2, including:

- Cancer
- Epilepsy
- Glaucoma
- HIV/AIDs
- Post-traumatic stress disorder (PTSD)
- Crohn's disease
- Parkinson's disease
- Multiple sclerosis
- Amyotrophic lateral sclerosis (ALS)

The law also states cannabis can be used to treat "other conditions of same kind or class." What does this mean? This means that a qualified physician can approve the use of medical cannabis for other conditions in which they feel the benefits would outweigh the risks. This allows the physician to determine if cannabis would be appropriate for a patient suffering from symptoms that are similar to those listed and is otherwise qualified. This may include, but is not limited to:

- Chronic pain
- Muscle spasms
- Anxiety
- Insomnia
- Seizures
- Nerve pain
- Nausea
- Loss of appetite
- Spasticity
- Abdominal pain and constipation
- Fibromyalgia
- Inflammatory conditions such as Irritable Bowel Syndrome (IBS)
- Arthritis
- Chronic Migraines



What routes of administration are currently available?

In Florida Medical Marijuana may be:

- Capsules
- Sublingual tinctures
- Oils
- Creams
- Vaporized through a device (vape pen)
- Sprays
- Edibles
